

## PROPORTIONED CORNER

GCDB 340100

Quarter Section corner on the Township line, Section 33, Township 35 South, Range 2 West and Section 4, Township 36 South, Range 2 West.

No evidence of the original BTs.

Set a 1" x 36" galvanized iron pipe ½ foot below the surface of the County road for corner on single proportion distance between the first section corner to the East and West from which ¼ section corner:

- A ¾" x 14" iron pin bears N.45¼°W. 42.56 feet
- Scribe a 12" ash tree which bears S.79½°E. 273.8 feet,
- A nail in the Northwest base of power pole #4584 bears S.9°E. 30.72 feet.

## FIRST RE-ESTABLISHMENT

GCDB 340100

Quarter corner common to Section 33, Twp. 35 South, Range 2 West and Section 4, Twp. 36 South, Range 2 West, W.M.

Found, 20 ins. below asphalt surface of road, the 1 ins. diam. iron pipe set by C. Z. Boyden (on proportionate measurement) in 1946. Reference: Jackson County Re-establishment (T35S) Book.

- A  $\frac{3}{4}$  ins. diam. iron bolt (with nut) brs. as recorded by Boyden: N45 $\frac{1}{4}$ °W, 42.56 feet.
- A Found, smooth iron pin,  $\frac{5}{8}$  ins. diam., projecting 1 ins. brs. S0°21'E, 30.00 feet.  
Reference: Survey No. 5363.
- A 2 ins. diam. black iron pipe, found 5 ins. deep, brs. S63°23'W, 66.91 feet. Reference: Survey No. 2127.
- A  $\frac{3}{4}$  ins. diam. iron pin, found flush with the surface of the road brs. N89°59'15"W, 30.00 feet.

**GCDB 340100**

Quarter corner common to Section 33, Twp. 35 South, Range 2 West and Section 4, Twp. 36 South, Range 2 West, W.M.

Found a 3 ins. diam. brass cap in monument well marked:

T35S R2W



T36S

Found references per First Re-establishment, dated 1979:

- 3/4 ins. diam. iron bolt 10 ins. below the ground bears N45°15' 00"W, 42.58 feet. Record 42.56 feet
- 3/4 ins. diam. iron pin flush with the asphalt at the intersection of Wheeler Rd. and Tresham Ln. bears S 89°58'22" W, 29.99 feet. Record: N89°59'15"W, 30 feet
- 5/8 ins. diam. smooth iron pin flush with ground approximately 1.5 feet west of fence post corner and approximately 4.5 feet Southwest from Power Pole No. B-11951 bears S0°05'57"E, 29.94 Record: S0°21'E, 30 feet
- 2 ins. diam. iron pipe 2 ins. below ground with nail in center located approx. 1 foot south of North-South bearing fence post corner, pipe falls under said fence, bears S63°19'47"W, 66.87 Record: S63°23'W, 66.91.

Corner falls in center line of Tresham Ln. approximately 30 feet east of the intersection of Wheeler Rd. and Tresham Ln. and approximately 15 feet South of Power Pole No. B-32851.

Note: Replaced monument well lid.
